Statement of Principles

Equestrian Canada Statement of Principles Equestrian Canada (EC), the national equestrian federation of Canada, supports adherence to humane treatment of horses in all activities under its jurisdiction.

EC is committed to:

- Upholding the welfare of the horses, regardless of value, as a primary consideration in all activities;
- Requiring that horses be treated with kindness, respect and compassion and that they never be subjected to mistreatment; ensuring that all equestrians including owners, trainers and competitors or their respective agents use responsible care in the handling, treatment and transportation of their own horses as well as horses placed in their care for any purpose;
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure;
- Providing current information on Code of Practice for the Care and Handling of Equines and other equine health and welfare initiatives;
- Continuing to support scientific studies on equine health and welfare;
- Requiring owners, trainers and competitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competition; and
- Reviewing, revising and developing competition rules and regulations that protect the welfare of the horses.

The standard by which conduct or treatment will be measured is that which a person, who is informed and experienced in generally accepted equine training and competition procedures, would determine to be neither cruel, abusive nor inhumane. (A602.3f)

All participants at the Trillium Hunter Jumper Association Championship Show are expected to abide by this Statement of Principles

The Trillium Championship Show is a Silver Sanctioned Competition of Equestrian Canada 11 Hines Rd., Suite 201 Ottawa ON K2K 2X1 and is governed by the rules of Equine Canada.(A602.1)

Every class offered herein which is covered by the rules and specifications of the current Equestrian Canada rules will be held and judged in accordance with the Equestrian Canada Rule Book. All questions not covered by these rules shall be decided by the show management whose decision will be final.

All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations (A602)

Per Article A801, Every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC- sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. (A602.7)

Any horse entered in any class at the competition may be selected for equine medication control testing while at the event location. (A602.5)

EC's concussion related Accidents and Return to Play Rule came into effect January 1st 2017 for all EC sanctioned competitions in Canada. The full rule can be found in the EC Rules Section A General Regulations Article 101.

The Show Management of the Trillium Championship Show reserves the right to cancel, change, alter, postpone, or update this publication, the show schedule, or any class or condition at any time they deem advisable.

Arrivals and Departures

- Arrivals officially open on Tuesday August 31st. Special permission can be granted to arrive on Monday August 30th for those travelling from a distance or with multiple trips.
- Stalls must be vacated by noon on Monday September 6th
- Ship ins are permitted but will be subject to a ship in fee of \$35 per horse

Stabling/Hay/Shavings

- Stabling Closing Date August 23rd 2021 at 4pm
- Stalls are available for the duration of the competition for \$185/week.
- Stabling is subject to availability and may be sold out prior to the closing date.
- Stall reservations are non refundable after the closing date.
- Bedding is not included in the price of the stall.
- Shavings and hay are available onsite for purchase through pre order on MyESM.
- At this time day stalls are not available.
- A stabling request form must be completed in order to reserve a stall.
- Hay and shavings may be ordered along with stall requests. Please complete the Hay/Shavings preorder form in advance and send it in along with your stall requests.
- Once delivered to the stalls (as indicated on stall chart) WCP is not responsible for any hay and shavings removed by unauthorized persons. All orders must be made in writing.

Facility Access and Night Security

- The show grounds will be secured overnight. Access overnight will need to be requested in advance.

Membership

- All Canadian owners and riders must have valid EC Silver Sport Licenses (A205), a provincial membership (Ontario Equestrian or equivalent) (A203) and a 2021 Trillium Hunter Jumper Association membership to compete at the Trillium Championship Show.
- Any USEF owners and riders must have a valid USEF membership, and a 2021 Trillium Hunter Jumper Association membership to compete at the Trillium Championship Show.
- THJA memberships cannot be purchased at or during the Trillium Championship Show.
- Competitors may not compete on Temporary Sport Licenses
- Anyone entered in an Amateur Division must have a current Equestrian Canada Amateur Card

Horse Recording Numbers

- All entries are required to have an Equestrian Canada Horse Recording Number and have paid the annual activation fee.
- Horses may not qualify or compete at the Trillium Championship Show on a temporary horse registration (A411.3).
- Exception: Hack Division competitors are not required to have Equestrian Canada Horse Recordings.

Entries

- Entry Closing Date: Sunday August 22nd
- Entries must be submitted through MyESM portal
- Late entries will be accepted subject to a \$50 post entry fee
- Please submit one entry per horse. All information must be filled in completely to be accepted. Incomplete entries will be assessed a \$25 incomplete fee.
- Class adds and scratches can be completed through MyESM prior to the closing date. After the closing date any class adds or scratches can be sent my email to

entries@wesleycloverparks.com or done in the office. These changes must be submitted by 4pm the date prior.

- Any adds completed at the ingate or after 4pm the day prior will be charged a \$10/class.
- Adds made the day of a competition will require the competitor to go first in the order of go.
- Questions can be sent to entries@wesleycloverparks.com or info@thja.ca
- Open cheques that are delivered to the show office when picking up back numbers will be accepted. Please make cheques payable to THJA
- No charges or changes will be accepted during the show without an open account
- A \$50 charge will be added to accounts that are not closed by the end of the show.
- A \$65 charge will be applied to any cheques that are returned for any reason (NSF Fee)
- Unsettled accounts will be turned over to EC at 30 days which will result in suspension from all competitions.
- Anyone having presented a non negotiable cheque to the THJA in the past will not be permitted to leave an open cheque for entries. They will be required to present cash for entries prior to receiving their number/stall.
- Failure to clear outstanding charges by October 1st 2021 from the Trillium Championship Show will result in disqualification for year end zone awards.
- Any person/business/barn failing to clear their account by the end of the year will be suspended as a THJA member for the following year
- Every pony entered in a pony division must have a valid Equestrian Canada pony measurement on file with Equestrian Canada. USEF pony measurement cards are also acceptable

Scratches

- All entry cancellations after the closing date must be made in writing to entries@wesleycloverparks.com
- Entries cancelled in writing at least 24 hours prior to the first class of the competition will be charged administration fee only.
- Entries that do not provide at least 24 hours notice will be charged a \$30 scratch fee and the administration fee.
- Refunds on entries are available only with a veterinarian or doctor's certificate.
- Stalls are non refundable after the closing date.

Administration

- Administration Fee: \$95
- Drug Testing Fee \$7
- THJA Development Fee: \$5
- Trainer splits must be made no later than noon on the Friday of competition, otherwise they will be charged to the barn bill.

Non Showing Horses

- Non showing horses must be registered and a \$50 fee per horse will be charged.
- All horses on the property must have a signed entry blank and both owner and rider must

provide a current OE of equivalent membership number.

- Non showing horses must abide by all Wesley Clover Parks rules.
- Any horse caught on the property without an entry blank on file will be charged an additional fine of \$100.

Schooling Classes

- Time and weather permitting schooling classes may be offered at the end of the day for a fee of \$40 per round. Multiple rounds are permitted.
- Riders must wear numbers.
- There will be no Hors Concours permitted at the competition.

Prize Money

- Prize money will be credited to each horse's account.
- Prize money cheques will be made payable to the owner of the entry, unless the office is notified to pay the rider.
- Cheques will be mailed within 21 days of the close of the competition.
- Cheques will only be issued to entries whose accounts have been paid in full.

Back Numbers

- Every entry will be provided with an identification number that must be worn and visible at all times in the schooling/exercise areas as well as the competition rings.
- Any horse wearing an incorrect number may not be scored.

Helmets

- Helmets are mandatory and must be worn by anyone mounted on a horse on the show grounds, with safety harness correctly fastened. It is the responsibility of the rider, the parent/guardian or trainer of the junior exhibitor to confirm headgear worn complies with appropriate safety standards, is properly fitted and is good condition.

Wesley Clover Parks Facility Rules

- Participants are only allowed to bathe their horses in designated areas. Owners who bathe their horses outside of those areas will be fined \$50/incident. Please do not tie horses to the fence at the wash racks
- Competitors are allowed to lunge in designated areas only (Top lunging rings). There will be no lunging in any of the all weather footing rings. A fine of \$100/incident will be charged to any horse account found lunging in the incorrect rings.
- Any costs incurred to repair damage to property belonging to Wesley Clover Parks including but not limited to stabling tents, soccer fields, bridges etc will be charged back to the responsible barn.
- Dogs must be kept on a leash at all times as per NCC regulations, this rule will be strictly enforced. The owners of any dog caught off leash will be fined \$100/incident. Owners are required to abide by the poop and scoop by law.
- Camping is not permitted onsite but can be booked at the neighbouring Wesley Clover Parks Campground.

- Please keep horses that are not under tack in the barn areas. Grazing at the show rings is not permissible during horseshow hours.
- There is no riding of horses permitted after dark.
- The Top Ring will be available for hacking and schooling purposes during horse show hours. We ask that if you are not entered in the divisions that are underway, that you refrain from using the show warm up rings during that time.

Blacksmiths and Veterinarians

- A farrier will be available onsite during competition days.
- All owners and exhibitors will be held responsible for any bills for veterinary and farrier services.
- Farrier and veterinarian contact info will be posted at the Wesley Clover Parks office.

Equine Health Requirements and Biosecurity

- The THJA and WCP endeavor to provide a health environment for all participants both human and equine. Through biosecurity proven good practices such as proof of vaccination for entry, our Only Healthy Horses Policy, and Equine Health Attestation and Agreement, regular stall disinfection, manure removal, the ability to isolate sick horses, access to veterinary care and hospitalization; WCP has a venue specific plan in place in the event of illness.
- **Proof of Vaccines:** Please upload an invoice or letter from your veterinarian indicating the horse's show name and date of administration of required vaccinations (As per EC Rules article A519)
- **Coggins Test:** Strongly suggested for all horses on site and must be available upon request at managements discretion.
- **Equine Health Attestation:** As part of WCP Healthy Horses Only Policy, each owner or trainer is required to complete an online Equine Health Attestation Form prior to arrival on site.

Championship Show Qualification Requirements

- ✓ Competitors may only collect points if they have a current THJA Membership.
- ✓ In each of the seven zones, the top seven (7) competitors in each division are eligible for Trillium Championship Show.
- ✓ Competitors must compete (Compete = Marked on a Judge's Card) at a minimum of TWO of the THJA Shows in the Zone.
- ✓ In the instance that someone in the top seven (7) of the division opts not to attend the Trillium Championship Show, the competitor in eighth (8th) place will be eligible to attend.
- ✓ Horse/rider combinations may only collect points in one of the THJA zones. The zone they wish to collect points in must be the zone on their THJA membership card.
- ✓ Riders are permitted to show in more than one zone, but they must have a THJA membership for each zone in which they will be collecting points.
- ✓ Both owners and riders must have THJA memberships to collect points towards Championship Show and Zone Awards.
- ✓ Points are not retroactive if memberships were not in place at the time of competition.
- ✓ Competitors may not collect points on Temporary Horse Licenses
- ✓ Points towards Championship Show and Zone Awards are calculated at each show based on the number of riders in the class, a standard multiplier factor, and the placings 1st to 6th. Please note that this is different than how points are calculated for Champion and Reserve Champion at individual horse shows.
- ✓ Entries will be verified for eligibility following submission

Prize Money Pay Outs

Membership Bonuses

Membership bonuses will be paid out from each members’ respective zone within 30 days of the completion of the Championship Show. Cheques will only be issued to those entries whose accounts have been paid in full.

Horse Show Etiquette

- All competitors must acknowledge the in gate person when called on deck.
- All trainer conflicts between rings must be declared to the in gates and resolved within the order of go.

- Any competitor missing their spot in the order will be moved to the end of the order, and given one warning call. Should the end of the class arrive, a ten minute call will be made for the competitor to enter the ring. After ten minutes, the ring will be closed.
- Course walks will open and close according to the schedule, and will not be held, altered, or reopened for any reason.
- The show rings will under no circumstances be held for conflicts caused by disorganization.
- Hunter Derbies and Mini Prix will run by posted order. No exceptions.
- The Judge's decision is final.

Horse Show Attire & Tack

- Formal show attire is required for all classes at the Trillium Championship Show.
- Draw reins will not be permitted in any classes.
- Horses must have proper tack as per EC Rules
- It is mandatory that all persons mounted on a horse anywhere on the competition grounds wear ASTM/SEI or BSI approved helmets secured with a safety harness permanently affixed to the helmet.
- All persons mounted on a horse must wear an exhibitor number

Vehicles

- All vehicles must be parked in designated areas only.
- There is NO PARKING on the roads or in the barn areas at any time.
- All motorized vehicles (including golf carts, scooters, dirt bikes, 4 wheelers, etc) must be operated by fully licensed drivers only.

EQUITATION

In the 2021 EC Rule Book, the guide for junior ages is:

Junior “A” – a rider who is 15, 16, 17 on January 1st.

Junior “B” – a rider who is 12, 13, 14 on January 1st.

Junior “C” – a rider who is under 12 on January 1st.

Junior “A” Riders may not ride “B” or “C” ponies.

Junior “B” Riders may ride “A”, “B”, or “C” ponies.

Junior “C” Riders may ride “A”, “B”, or “C” ponies.

For show purposes, ponies are to be divided as follows:

“A” ponies – over 13.2 hands, but not to exceed 14.2 hands

“B” ponies – over 12.2 hands, but not to exceed 13.2 hands

“C” ponies – do not exceed 12.2 hands

- Trillium “A” Equitation Over Fences – Open to Large Pony Division riders with fences at 2’9”; Children’s Division riders with fences at 3’; and Trillium Low/High division riders with fences at 3’3”.
- Adult Equitation – Adult Equitation Riders must be Amateurs.
- A horse or pony ridden in an Equitation Class Over Fences, or in the Jumper Medal Class may only be ridden in that class by one rider.
- In the event that a rider competes in two different divisions requiring them to jump different heights, it will be their choice which height they will jump for the equitation over fences class. This choice needs to be indicated on the entry form.

(Eligibility as per EC Rules)

Trillium Hunter Medals

Originally created in the image of the Jump Canada Medal, the Trillium Medal Class has evolved into a specialty class unique to the Trillium Circuit. Where a contradiction exists, these specifications supersede those of the Equestrian Canada Jump Canada Medal. These classes are open to Junior and Amateur riders only. Riders may walk the course. Eligibility as per individual hunter division specs for that particular medal.

First Phase - Over Fences: Figure eight course of not less than eight jumps. Class is judged in accordance to Article G1008 Class Routine Over Fences. No additional tests over fences are permitted.

Second Phase - On The Flat: All contestants, or a minimum of ten shall be called back to perform at a walk, trot and canter. From a maximum of four competitors, the judge may call for a minimum of two or more requirements from Article G1009 Tests (Equestrian Canada Rule Book Section G)

Scoring: Medal classes will be judged 60% over fences and 40% on the flat.

Tack & Equipment: All tack and equipment remains the same for both phases. Restrictions as per Article G1003 through G1005 (Equestrian Canada Rule Book Section G)

Provincial Equitation Finals Ride Off

The top two placings in each equitation and medal class will each receive an invitation to the Trillium Championship Provincial Equitation Ride Off to take place on the grass derby field at the end of the schedule on Saturday. Participants will be tested by the judging panel on the flat only, to determine the top equitation rider as part of the celebration of the Trillium Championship Show Equitation Finals! The judging panel will award the top three placings. Good luck to all our equitation riders!

\$5000 Bright Futures Medal Series Finals

Generously sponsored by Sean Jones

Open to all A Equitation riders across all zones in Ontario. Combined equitation score (over fences and under saddle) throughout the season will enter the rider into the final competition at the Trillium Championships. A leaderboard will tally rider scores over the season with an

accumulated score with the top 20 eligible to compete in the final. Final will consist of an over fences phase with the top 10 riders coming back to test on the flat. Winner will receive a \$2500 RESP contribution, cooler, medal and rosette. Placings 2nd-6th will receive an RESP contribution of a portion of \$2500, medals and rosettes. Eligibility as per A Equitation rules of the THJA.

Trillium Jumper Medal: Fences not to exceed 3'3"

Originally created on the image of the CET Medal, the Trillium Jumper Medal has evolved into a specialty class unique to the Trillium Circuit. These specifications supersede those of the Equestrian Canada CET medal. The class will have both a jumping phase and a flat phase. This class is open to Junior and Amateur riders only. It is judged as an equitation class with both a jumping and flat phase. Jumping phase to be ridden first.

Tack & Equipment: All tack and equipment remains the same for both phases. Only running martingales used in the conventional manner are permitted. No standing martingales, draw reins or restricted running martingales are permitted. Conservative coloured headgear (As per Article G1109) with no additional adornment. Stirrups are restricted as per Article G1109-G)

Judging: Jumping phase to be conducted under current Equine Canada jumper rules. In addition, the class will be judged on seat, hand, guidance and control. Jumper Medal to be judged 60% over fences and 40% on the flat.

Jumping Phase: The jumping phase should be over a course of at least nine (9) fences. Fences will not exceed 3'3" in height with a spread not to exceed the height. The course must contain at least one double or triple combination with at least one spread fence. Other spread fences are required elsewhere on the course. A Liverpool is optional.

Flat Phase - All riders, or a maximum of twelve who complete the Jumping Phase, shall be called back to perform on the flat. During the flat phase, riders will show a working walk, the working trot sitting, the working trot rising, and showing a lengthening of stride, the working canter and the working canter showing a lengthening of stride. The working canter on the counter lead must be demonstrated for at least one full revolution of the ring in each direction. The top four riders in the flat phase may be asked to complete a short test determined by the judge. When this test is being ridden, the riders will turn their backs so they cannot watch the other competitors.

Hunter Divisions

Small Pony Hunter Division: Fences 2'3"

Open to ponies not exceeding 12.2hh. Small pony riders must be 14 years of age and under as of January 1st of the competition year.

Medium Pony Hunter Division: Fences 2'6"

Open to ponies exceeding 12.2hh, but not exceeding 13.2hh. Medium pony riders must be 14 years of age and under as of January 1st of the competition year.

Large Pony Hunter Division: Fences 2'9"

Open to ponies exceeding 13.2hh, but not exceeding 14.2hh. Large pony riders must be 17 years of age and under as of January 1st of the competition year.

Modified Pony Hunter

Open to all ponies. Ponies will jump 3" below their regular pony hunter division height and distances will be adjusted according to pony size as per EC Rules G306.6.A. Age restrictions as per EC Rules G306.1. Pony/rider combinations may not cross enter into any other classes or divisions requiring them to jump.

Small – Not to exceed 2'

Medium – Not to exceed 2'3"

Large – Not to exceed 2'6"

Short Stirrup Division: Fences not to exceed 21"

Open to "C" riders. Fences will not exceed 21 inches and the course will be comprised of a maximum of eight fences. Course to consist of verticals only, no oxers. Short stirrup riders may not enter any other classes except for "C" Equitation on the flat and My First Medal. Open to both horses and ponies, but lines (distances) will not be adjusted. Ideally, horse and rider combination are able to ride all lines with the same consistency in rhythm and pace. In the event that a Short Stirrup rider has two mounts, the second mount must be jogged and flatted by another rider who is eligible for the Short Stirrup division. Attire as per Article G109.

Adult Amateur Hunter: Fences 3'

As per Equestrian Canada Article G309. All adults competing in amateur classes at EC-sanctioned competitions must possess a current EC amateur card, which is purchased annually at the price listed in the EC Schedule of Fees. Riders in this division may cross enter to the low option of the Trillium Hunter Division and compete at 3'3".

Modified Adult Amateur Hunter Division: Fences 2'9"

Riders in this division must hold a current Amateur card. A horse/rider combination may only cross enter into the Hack Division, the Low/High Hunter Development Division, the Modified Children's Trillium Medal, and their age appropriate equitation on the flat class. The rider may enter in any other division or class at that show on another horse or pony. The horse may be shown in another class/division with another rider. This division may be combined with the Modified Children's Hunter Division throughout the season, but will be split at Championship Show.

2'6" Amateur Division

Open to adult amateurs riding horses. Riders are not eligible to compete in any division with a height over 2'6", except for the Low/High Hunter Development Division. Horse/rider combinations are permitted to also show in the Low/High Hunter Development Division, Hack Division and their age appropriate equitation on the flat.

Children's Hunter: Fences 3'0"

Open to horses ridden by a junior. As per Equestrian Canada Rules Article G307.

Modified Children's Hunter Division: Fences 2'9"

Open to juniors riding horses. A horse/rider combination may only cross enter into the Hack Division, the Low/High Hunter Development Division, the Modified Children's Trillium Medal, and their age appropriate equitation on the flat class. The rider may enter in any other division or class at that show on another horse or pony. The horse may be shown in another class/division with another rider. This division may be combined with the Modified Adult Hunter Division throughout the season, but will be split at Championship Show.

2'6" Children's Division

Open to juniors riding horses. Riders are not eligible to compete in any division with a height over 2'6", except for the Low/High Hunter Development Division. Horse/rider combinations are permitted to also show in the Low/High Hunter Development Division, Hack Division and their age appropriate equitation on the flat.

Low/High Open Hunter Division: Fences 2'6" and 2'9"

This division is open to all horses. No ponies are permitted. Horse and rider combinations may only cross enter to the 2'6" Children's or 2'6" Amateur Hunter divisions, Modified Children's or Modified Adult Amateur Hunter Division, the Hack division, and their age appropriate equitation on the flat. Competitors may move both up and down in heights between shows, but competitors may not change heights once the division has started. Competitors must declare height on their Championship Show Entry Form.

Low Hunter: Fences 3'

Open to all horses.

Trillium Hunter – Low/High: Fences 3'3" and 3'6"

The low option of this division is open to all riders.

The high option of this division is not open to Children's or Adult Amateur Division riders.

Hack Division

As per Equestrian Canada Chapter 12 and 13 – Classes Refer to Article G1301-1303

JUMPER DIVISIONS

0.90M Jumper Division

Open to all horses and ponies. Maximum height of fences .90m. Run under Table A.

1.0M Jumper Division

Open to all horses, and to ponies who are ridden by juniors. Adults are not permitted to ride ponies in this division. Maximum height of fences 1 Metre. Run under Table A.

1.10M. – Trillium Jumper Division

Standing Martingales, German martingales and draw reins are not allowed for any competitor in this division. Junior/Amateurs may cross enter into this division. Run under Table A.

Specialty Classes

Mini Prix

Open to all horses who have shown at the 2021 Trillium Championships. The course will consist of a twelve obstacle first round, and a shortened jump off to follow after each competitor has completed the first round. Riders must be present and mounted for presentations.

****Mini Prix will run by posted order. No exceptions.****

Pony & Hunter Derbies

Derby to consist of one round with each horse receiving a numerical score. The first round will consist of a hunter course with at least 12 jumps.

1. Hunter score (out of 100) - The class is judged as a handy hunter class with a score
2. High performance bonus (up to 10 bonus points) - Two bonus points awarded for each high performance option taken on course (e.g., higher jump, natural jumps, more challenging line options), at least three options will be offered on course)
3. Handy bonus (up to 10 bonus points) – Zero to ten additional bonus points awarded at the

judge's discretion for additional handiness and high performance displayed on course, including: Unique turns and approaches, inside turns, slices, athleticism and boldness (e.g., big gallop to jumps), impressionable start and finish.

There will be a course walk for this class.

Horses must be jogged (mounted) for soundness.

****Derbies will run by posted order. No exceptions.****

Pony Derby

Open to any pony that has shown at the 2021 Trillium Championships. Offered at regulation height for ponies.

Grass Ring Derby

Open to any horse that has shown at the 2021 Trillium Championships. Offered at 2'6, 2'9 and 3' heights.

Mini Prix

Open to any horse shown at the 2021 Trillium Championships. Offered at .90M, 1M and 1.10M heights.

Lead Line Class

For children up to the age of 7. Entry fee is \$10. Leaders must be at least 16 years of age. Please complete an entry blank so the announcer knows your child and their mount's names.
